3. The Wright funds have no sales charge and their annual expense ratio is limited by a contractual agreement with the advisor and distributor. The agreement, if not renewed, will expire April 30, 2017. In addition, the advisor voluntarily further limited the expense ratio of the WCIFX from the contractual limit of 1.00% to 0.90%. Such voluntary limitation may be terminated at any time. If the agreement were not in place, the expense ratios would be WQCEX 2.20%, WSBEX 1.42%, WIBCX 2.23%, and WCIFX 1.14%.
